9 SYLLABUS OF FIELD WORK PRACTICUM

There shall be two types of field work : (i) concurrent field work, and (ii) Block placement. Concurrent Field work will be required to be done simultaneously with class-room teaching of theory papers from the very beginning of the session up to the preparation leave before the commencement of the examination. Every student will be required to go for concurrent field work for three days in week (excluding Holidays and Dusehara and winter Vocations). Concurrent field work will be of 100 Marks in each Semester.

Block placement through placement in any reputed industrial organization or Non-Organization or social welfare agency of Government Organization for six weeks after the end of fourth semester will be organized just after the end of theory papers. The student will submit weekly report of the work done to the supervisor and on his/her recommendation marksheet/degree will be released by the examination section of Nehru Gram Bharti University, Allahabad.

In semester Fourth Field Based Action Research shall be 100 marks. In M.S.W. Fourth semester, in addition fo theory examination and evaluation of Concurrent Field work (Inclusive of field Based Research Report), there be a general Viva-Voce Examination of 100 marks to ascertain the comprehension of the subject and ability to communicate in face to face situations.

Every student will be required to pass separately in theory papers, field work ad general Viva-Voce examination. In order to successfully pass, every student will be required to obtain at least 40% marks in the aggregate of theory papers, field work and general Viva-Voce Examination. Maximum Six attempts should be given for clearing Back Paper's.

10 STUDY TOUR

Every student, after completing second semester examination will be required to for study Tour. This Study tour will be Organized at that place where Social work Institution are in function.

11 PROJECT REPOST

Each student shall be required to prepare and submit a project Report on the theme which will be decided in consultation with Social Work Educators, before the commencement of the Third Semester.

12 ATTENDANCE

Seventy five percent attendance in theory Lectures and hundred percent in field work shall be compulsory. 30 days in each semester and 06 Hour for each days.

13 FEE

Fee will be charged as per Nehru Garm Bharti University, Allahabad norms and fee structure revises form time to time.
